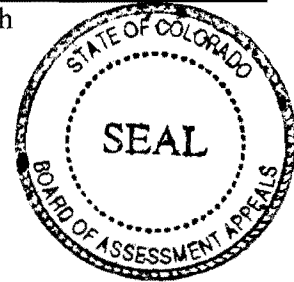

Based on further review an adjustment was warranted.


