**STIPULATION (As to Tax Year 2009 Actual Value)**

Petitioner and Respondent hereby enter into this Stipulation regarding the tax year 2009 valuation of the subject property and jointly move the Board of Assessment Appeals to enter its order based on this Stipulation.

The Petitioner and Respondent agree and stipulate as follows:

1. The property subject to this Stipulation is described as:

Lot 12, Blk 14, Town of Castle Rock. 0.161 AM/L.

2. The subject property is classified as Commercial property.

3. The County Assessor originally assigned the following actual value on the subject property for tax year 2009:

Commercial Imps. Bldg 2	\$ 17,433
Total	\$522,333

4. After a timely appeal to the Board of Equalization, the Board of Equalization valued the subject property as follows:

Residential Land	\$ 58,920
Residential Imps. Bldg 1	\$117,806
Commercial Imps. Bldg 2	\$ 17,433
Total	\$522,333

5. After further review and negotiation, the Petitioner and the Douglas County Board of Equalization agree to the following tax year 2009 actual value for the subject property:

Commercial Land	\$109,392
Commercial Imps. Bldg 1	\$127,226
Residential Land	\$ 58,920
Residential Imps. Bldg 1	\$ 7,407
Residential Imps. Bldg 2	\$ 17,433
Total	\$320,378

6. The valuations, as established above, shall be binding only with respect to tax year 2009.

7. Brief narrative as to why the reduction was made:

Further review and correction of various attributes impacting the subject property warranted a reduction in value.

8. A hearing has not been scheduled before the Board of Assessment Appeals.


