| <b>STIPULATION (AS TO TAX YEAR 2009 ACTUAL VALUE)</b>   |  |

Petitioner, SCOTT D. AND DEBRA WYLIE, and Respondent, BOARD OF EQUALIZATION OF THE CITY AND COUNTY OF DENVER, hereby enters into this Stipulation regarding the tax year 2009 valuation of the subject property, and jointly move the Board of Assessment Appeals to enter its order based on this Stipulation.

The Petitioner(s) and Respondent agree and stipulate as follows:

2. The subject property is classified as residential/commercial property.

3. The County Assessor originally assigned the following actual value on the subject property for tax year 2009.

6. The valuations, as established above, shall be binding only with respect to tax year 2009.

7. Brief narrative as to why the reduction was made:

Per further review of the sales in the subject's complex, the dollar per sq. ft. had a decline towards the end of the base period, thus warranting an adjustment.

8. Both parties agree to be responsible for their own costs, expert and attorney fees, waiving any claim against each other for such, and agree that any hearing before the Board of Assessment Appeals not be scheduled or be vacated if already scheduled.
