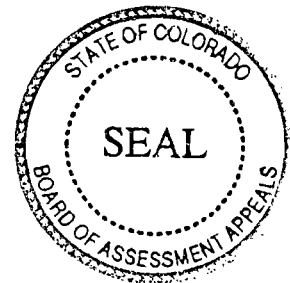

7. Brief narrative as to why the reduction was made:


A review of the subject's information indicated a lower value.


