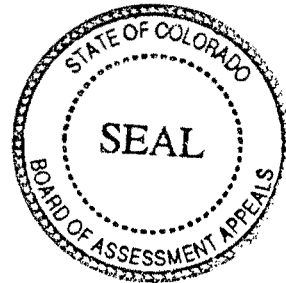

STIPULATION (AS TO TAX YEAR 2009 ACTUAL VALUE)	

Petitioner, 1460 LITTLE RAVEN LLC, and Respondent, BOARD OF EQUALIZATION OF THE CITY AND COUNTY OF DENVER, hereby enter into this Stipulation regarding the tax year 2009 valuation of the subject property, and jointly move the Board of Assessment Appeals to enter its order based on this Stipulation.

The Petitioner(s) and Respondent agree and stipulate as follows:

1. The property subject to this Stipulation is described as:

1450 Little Raven Street
Denver, Colorado 80202
2. The subject property is classified as commercial real property.

3. The County Assessor originally assigned the following actual value on the subject property for tax year 2009.

Land	\$ 12,585,900.00
Improvements	\$ <u>49,221,100.00</u>
Total	\$ 61,807,000.00

4. After appeal to the Board of Equalization of the City and County of Denver, the Board of Equalization of the City and County of Denver valued the subject property as follows:

Land	\$ 12,585,900.00
Improvements	\$ <u>47,354,100.00</u>
Total	\$ 59,940,000.00

5. After further review and negotiation, the Petitioner and Board of Equalization of the City and County of Denver agree to the following actual value for the subject property for tax year 2009.

Land	\$ 12,585,900.00
Improvements	\$ <u>44,414,100.00</u>
Total	\$ 57,000,000.00

6. The valuations, as established above, shall be binding only with respect to tax year 2009.

7. Brief narrative as to why the reduction was made:


Through negotiations with the Deputy Assessor, the value has been reduced to \$57,000,000.

8. Both parties agree to be responsible for their own costs, expert and attorney fees, waiving any claim against each other for such, and agree that any hearing before the Board of Assessment Appeals not be scheduled or be vacated if already scheduled.


