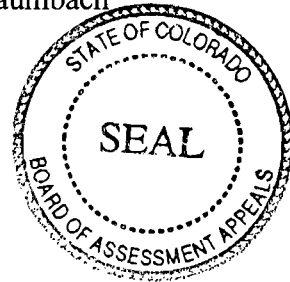

Per further review of Market data and comparables.


