3. The County Assessor originally assigned the following actual value on the subject property for tax year 2009.

4. After appeal to the Board of Equalization of the City and County of Denver, the Board of Equalization of the City and County of Denver valued the subject property as follows:

5. After further review and negotiation, the Petitioner and Board of Equalization of the City and County of Denver agree to the following actual value for the subject property for tax year 2009.

Improvements	\$ <u>16,706,900.00</u>
Total	\$ 19,440,000.00

6. The valuations, as established above, shall be binding only with respect to tax year 2009.

7. Brief narrative as to why the reduction was made:


After negotiations with the property tax agent handling this appeal, it was agreed to assign the subject \$90,000 per unit.


