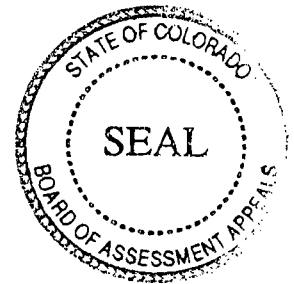

6. The valuations, as established above, shall be binding only with respect to tax year 2009.


7. Brief narrative as to why the reduction was made:

The base period rent rolls and operating statements for the subject property were thoroughly reviewed and it was determined that a lesser value was indicated.


