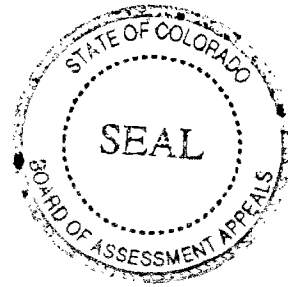

Based on further review of available market data, an adjustment was warranted.


