| <b>STIPULATION (AS TO TAX YEAR 2009 ACTUAL VALUE)</b>   |   |

Petitioner, GRE BEAR VALLEY, LLC, and Respondent, BOARD OF EQUALIZATION OF THE CITY AND COUNTY OF DENVER, hereby enter into this Stipulation regarding the tax year 2009 valuation of the subject property, and jointly move the Board of Assessment Appeals to enter its order based on this Stipulation.

The Petitioner(s) and Respondent agree and stipulate as follows:

1. The property subject to this Stipulation is described as:

 Denver, Colorado 80227

2. The subject property is classified as commercial real property.

3. The County Assessor originally assigned the following actual value on the subject property for tax year 2009.

7. Brief narrative as to why the reduction was made:

Excess vacancy has been recognized. However the adjustment and the above dollar figures pertain to only a single property identification number (PIN). Only 05313-00-046-000 will receive the excess vacancy allowance. All other PINs in this appeal remain UNCHANGED. See attachment for complete listing of PINs & values.


