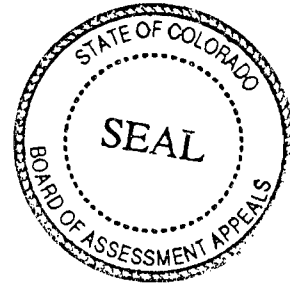

7. Brief narrative as to why the reduction was made:


Further analyses of the make-up of the subject's excess vacancy problems in the income approach and reviews in the other approaches to value were made.
