4. The Board concurs with the Stipulation.


**ORDER:**



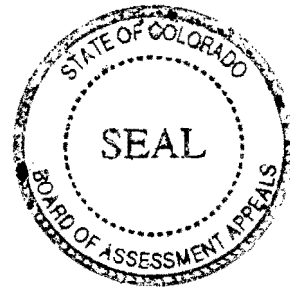

6. The valuations, as established above, shall be binding only with respect to tax years 2009.


