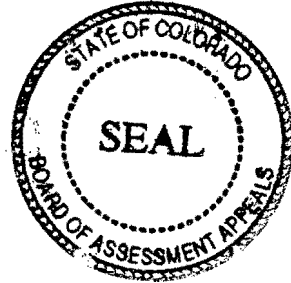

6. The valuations, as established above, shall be binding only with respect to tax years 2007 and 2008.


7. Brief narrative as to why the reduction was made:
