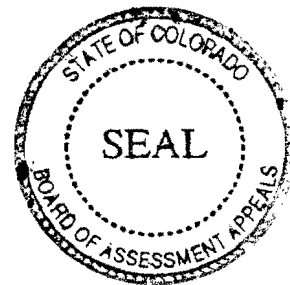

STIPULATION (AS TO TAX YEAR 2010 ACTUAL VALUE)	

Petitioner, ROHR INVESTMENTS INC. and Respondent, BOARD OF EQUALIZATION OF THE CITY AND COUNTY OF DENVER, hereby enter into this Stipulation regarding the tax year 2010 valuation of the subject property, and jointly move the Board of Assessment Appeals to enter its order based on this Stipulation.

7. Brief narrative as to why the reduction was made:

Based on further review of the subject, its neighborhood and potential absorption of the land parcels, the present worth discount of the market value was adjusted to \$55.00/sf for tax year 2010.

8. Both parties agree to be responsible for their own costs, expert and attorney fees, waiving any claim against each other for such, and agree that any hearing before the Board of Assessment Appeals not be scheduled or be vacated if already scheduled.
