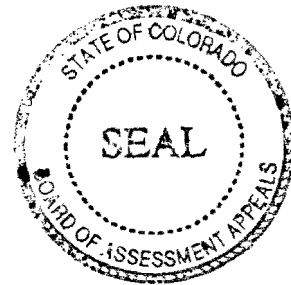

<b>STIPULATION (AS TO TAX YEAR 2010 ACTUAL VALUE)</b>
