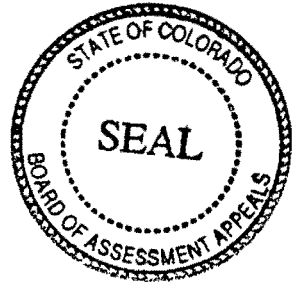

The value was adjusted after review of market sales.


