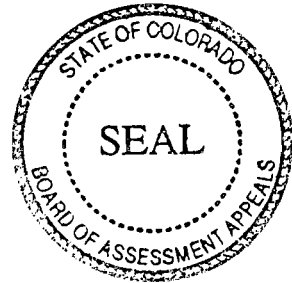

A brief narrative as to why the reduction was made: Extended 2009 value after final appeal.






The valuation, as established above, shall be binding only with respect to the tax year 2010.
