A brief narrative as to why the reduction was made: Applied 2009 value after final appeal. No unusual conditions between January 1, 2009 and January 1, 2010.


The parties have agreed that the 2010 actual value of the subject property should be reduced as follows:




The valuation, as established above, shall be binding only with respect to the tax year 2010.
