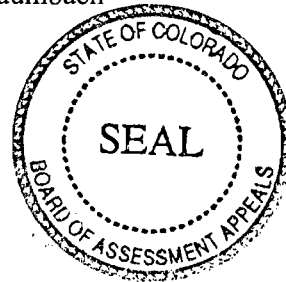

A brief narrative as to why the reduction was made: Applied 2009 value after final appeal.


The parties have agreed that the 2010 actual value of the subject property should be reduced as follows:




The valuation, as established above, shall be binding only with respect to the tax year 2010.
