STIPULATION (As to Tax Year 2011 Actual Value)

Petitioner and Respondent hereby enter into this Stipulation regarding the tax year 2011 valuation of the subject property, and jointly move the Board of Assessment Appeals to enter its order based on this stipulation.

Petitioner and Respondent agree and stipulate as follows:

1. The property subject to this stipulation is described as

**19687 Highway 131
Bond, Colorado**

2. The subject property is classified as **Residential**

3. The County Assessor originally assigned the following actual value to the subject property for tax year 2011:

Land	\$ 85,970.00
Improvements	\$ 41,420.00
Total	\$ 127,390.00

4. After a timely appeal to the Board of Equalization, the Board of Equalization valued the subject property as follows:

Land	\$ 85,970.00
Improvements	\$ 41,420.00
Total	\$ 127,390.00

5. After review and negotiation, Petitioner and County Board of Equalization agree to the following tax year 2011 actual value for the subject property:

Land	\$	85,970.00
Improvements	\$	28,400.00
Total	\$	114,370.00

6. Brief narrative as to why the reduction was made:

An inspection of all the buildings on the subject parcel was performed which revealed an older homestead with 2 SFR improvements, an out building/storage building and a garage for the Rock Creek Volunteer Fire Department. These improvements definitely showed varying forms of deferred maintenance and age. After confirming dimensions, quality and other aspects of the improvements, some adjustments were warranted.

7. The valuation, as established above, shall be binding only with respect to tax year 2011.

8. A hearing has been scheduled before the Board of Assessment Appeals for November 8, 2011 at 8:30 a.m. and should be vacated upon the Board's acceptance of this Stipulation Agreement.
