<p>MOTION TO WITHDRAW</p>	

Petitioner, THF Prairie Center Development, L.L.C., a Colorado limited liability company (“THF”), by its attorneys, Otten, Johnson, Robinson, Neff & Ragonetti, P.C., hereby submits its Motion to Withdraw, and in support thereof, states as follows:

1. Petitioner THF filed appeals to the Board of Assessment Appeals (“BOAA”) on August 31, 2012 with respect to parcel Schedule Nos. R0147817 (Docket No. 58140), R0006925 (Docket No. 58141), R0006918 (Docket No. 58142), R0006919 (Docket No. 58143), and R0006910 (Docket No. 58144) (collectively, the “**Real Property Parcels**”).
2. On March 22, 2012, the BOAA issued Notices of Hearing for all of the Real Property Parcels, excluding parcel Schedule No. R0006918 (Docket No. 58142), for June 11, 2012; June 12, 2012 and June 13, 2012.


3. At the request of Petitioner THF to reschedule the March 22, 2012 hearings, on June 1, 2012, the BOAA entered an order vacating the June 11, 12 and 13, 2012 hearing dates for the Real Property Parcels.
4. On July 3, 2012, the BOAA issued a Notice of Hearing for parcel Schedule No. R0006918 (Docket No. 58142) for December 4, 2012 at 8:30 a.m.
5. On July 16, 2012, the BOAA issued Notices of Hearing for the remaining Real Property Parcels, R0147817 (Docket No. 58140), R0006925 (Docket No. 58141), R0006919 (Docket No. 58143), and R0006910 (Docket No. 58144), for December 4, 2012 at 8:30 a.m..
6. Petitioner THF has reviewed and examined the applicable documentation and information related to Adams County's valuation of the Real Property Parcels, and, based upon such review and examination, has determined to not further pursue this action.
7. The claims at issue with respect to Docket No. 58140, Docket No. 58141, Docket No. 58142, Docket No. 58143 and Docket No. 58144 have been resolved.
8. Counsel for the Petitioner has conferred with the Adams County regarding this withdrawal and they have no objection.

WHEREFORE, the law firm of Otten, Johnson, Robinson, Neff & Ragonetti, P.C. hereby respectfully requests that the Board of Assessment Appeals accept its motion to withdraw Docket No. 58140, Docket No. 58141, Docket No. 58142, Docket No. 58143 and Docket No. 58144.

FURTHER, counsel for Petitioner requests that each party be responsible for their own attorneys fees and costs.
