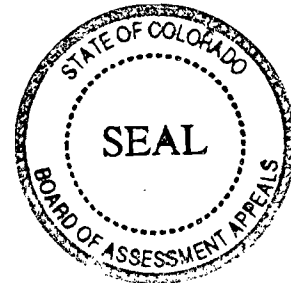

Petitioners and Respondent hereby enter into this Stipulation regarding the tax year 2011 valuation of the subject property, and jointly move the Board of Assessment Appeals to enter its order based on this stipulation.

Petitioners and Respondent agree and stipulate as follows:

1. The property subject to this stipulation is described as

**107 Rockledge Road  
Vail Village First Filing  
Raether Minor Sub Block 7**

2. The subject property is classified as **Residential**.

3. The County Assessor originally assigned the following actual value to the subject property for tax year 2011:

Land	\$ 7,869,880.00
Improvements	\$ 11,076,150.00
Total	\$ 19,007,360.00

4. After protest, the County Assessor assigned the following actual value to the subject property for tax year 2011:

Land	\$ 7,567,190.00
Improvements	\$ 8,949,310.00
Total	\$ 16,516,500.00

5. After a timely appeal to the Board of Equalization, the Board of Equalization valued the subject property as follows:

Land	\$ 7,567,190.00
Improvements	\$ 8,014,810.00
Total	\$ 15,582,000.00

6. After review and negotiation, Petitioners and County Board of Equalization agree to the following tax year 2011 actual value for the subject property:

Land	\$ 7,567,190.00
Improvements	\$ 6,432,810.00
Total	\$ 14,000,000.00

7. Brief narrative as to why the reduction was made:

**The stipulated value was agreed upon by Petitioners and Eagle County during pre-hearing discussions.**

8. The valuation, as established above, shall be binding only with respect to tax year 2011.

9. A hearing has been scheduled before the Board of Assessment Appeals for March 26, 2012 at 8:30 a.m. and should be vacated upon the Board's acceptance of this Stipulation Agreement.
