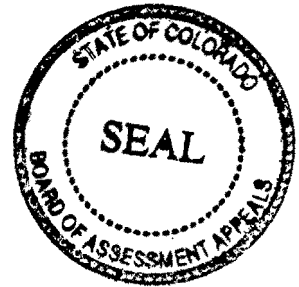

STIPULATION (As To Tax Year 2011 Actual Value)
