Total	\$ 6,500,000


6. The valuation, as established above, shall be binding only with respect to tax year 2011.


7. Brief narrative as to why the reduction was made: Market rents increased, excess vacancy, location, low demand, mill levy increases and higher cap rates validated a change in value.
