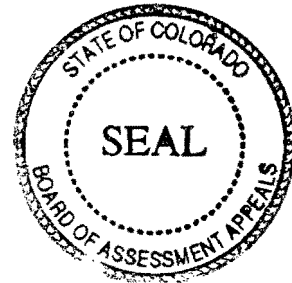

Petitioner and Respondent hereby enter into this Stipulation regarding the tax year 2011 valuation of the subject property, and jointly move the Board of Assessment Appeals to enter its order based on this stipulation.

Petitioner and Respondent agree and stipulate as follows:

1. The property subject to this stipulation is described as

2. The subject property is classified as **Commercial**.
3. The County Assessor originally assigned the following actual value to the subject property for tax year 2011:

Improvements	\$ 19,158,940.00
Total	\$ 28,796,740.00

4. After a timely appeal to the Board of Equalization, the Board of Equalization valued the subject property as follows:

Land	\$ 9,637,800.00
Improvements	\$ 15,512,200.00
Total	\$ 25,150,000.00

5. After review and negotiation, Petitioner and County Board of Equalization agree to the following tax year 2011 actual value for the subject property:

Land	\$ 9,637,800.00
Improvements	\$ 11,368,940.00
Total	\$ 21,006,740.00


6. Brief narrative as to why the reduction was made:


