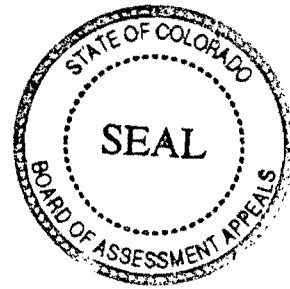

3. The County Assessor originally assigned the following actual value to the subject property for tax year 2011:
