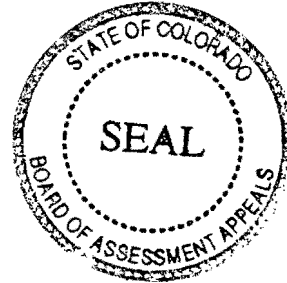

7. Brief narrative as to why the reduction was made:


Further review of market information indicates a reduction.
