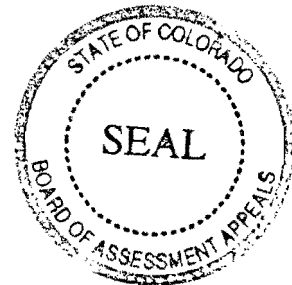

7. Brief narrative as to why the reduction was made:


The rentable area of the two units were adjusted based on the submitted rent roll.
