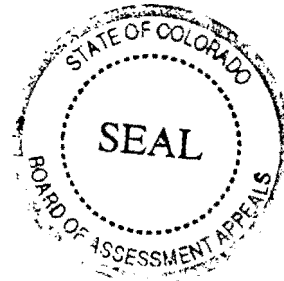

The Petitioner and Respondent agree and stipulate as follows:

1. The property subject to this Stipulation is described as:
Lot 2, Block 1 1st Bank of Douglas County. 1.303 AM/L.

2. The subject property is classified as Commercial property.

3. The County Assessor originally assigned the following actual value on the subject property for tax year 2011:

4. After a timely appeal to the Board of Equalization, the Board of Equalization valued the subject property as follows:

Total	\$1,221,114


6. The valuations, as established above, shall be binding only with respect to tax year 2011.

7. Brief narrative as to why the reduction was made:


Further review of account data and market sales information on comparable properties indicated that a change in value was warranted.
