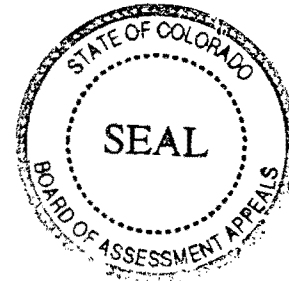

7. Brief narrative as to why the reduction was made:


Based on further review of market data, an adjustment is warranted.


