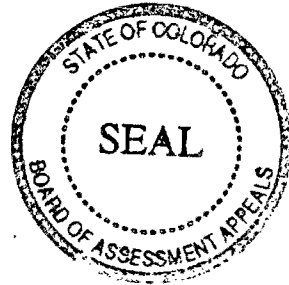

Based on further review of market data, an adjustment is warranted.


