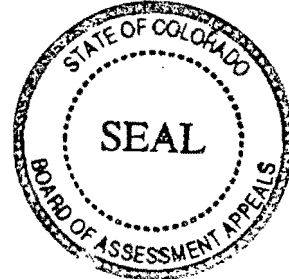

<b>STIPULATION (AS TO TAX YEAR 2011 ACTUAL VALUE)</b>

The Petitioner(s) and Respondent agree and stipulate as follows:

2. The subject property is classified as parking; residential and commercial property.

3. The County Assessor originally assigned the following actual value on the subject property for tax year 2011.

4. After appeal to the Board of Equalization of the City and County of Denver, the Board of Equalization of the City and County of Denver valued the subject property as follows:

5. After further review and negotiation, the Petitioner and Board of Equalization of the City and County of Denver agree to the following actual value for the subject property for tax year 2011. 6. The valuations, as established above, shall be binding only with respect to tax year 2011.

7. Brief narrative as to why the reduction was made:
