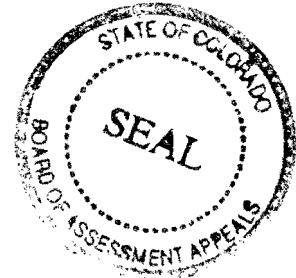

7. Brief narrative as to why the reduction was made:


The recognition of the subject rental rates resulted in a reduction.


