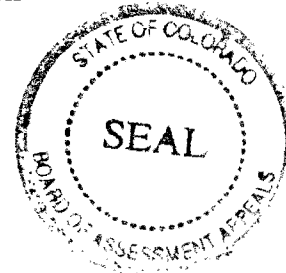

Further review of available market data resulted in a change in value.


