


BOTH PARTIES stipulate and agree as follows:

This information includes actual rent rolls, together with operating income and expense information of the property, ~~which will be provided to the Assessor no later than March 15th of each year.~~ *required pursuant to CRS 39-8-107* (KG) 
6. ~~Petitioner(s) agrees to allow access to the improvements for the purposes of measuring or to obtain building condition information during normal business hours.~~ (KG)
