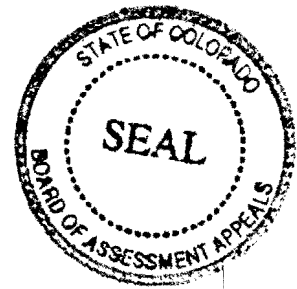

A brief narrative as to why the reduction was made. Applied 2011 value after final appeal.


The parties have agreed that the 2012 actual value of the subject property should be reduced as follows:


