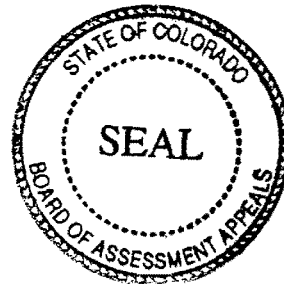

This information includes actual rent rolls, together with operating income and expense information or the property, ^{CRS 31-8-107 (KG)} which will be provided to the Assessor no later than March 15th of each year.
