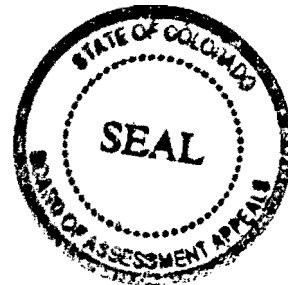

Petitioner and Respondent hereby enter into this Stipulation regarding the tax year 2012 valuation of the subject property, and jointly move the Board of Assessment Appeals to enter its order based on this stipulation.

Petitioner and Respondent agree and stipulate as follows:

3. The County Assessor originally assigned the following actual value to the subject property for tax year 2012:

Total	\$ 711,890


6. Brief narrative as to why the reduction was made:
