Petitioner, WL and Gayle Hunt, and Respondent Pitkin County Board of Equalization hereby enter into this Stipulation regarding the tax year 2012 valuation of the subject property, and jointly move the Board of Assessment Appeals to enter its order based on this Stipulation.

The Petitioner and Respondent agree and stipulate as follows:

1. The property subject to this stipulation is described as Stage Road P.U.D, lot 3, and is identified as Parcel No. 2735 023 03 003 in Pitkin County Assessor's Office records.
2. After a timely appeal to the Board of Equalization, the Board of Equalization valued the subject property as follows:

Agricultural Land:	\$ 1,200
Non-Integral Residential Land:	\$ 3,250,000
Residential Improvements:	<u>\$ 1,900,600</u>
Total:	\$ 5,151,800


3. After further review and negotiation, the Petitioner and County Board of Equalization agree to the following tax year 2012 actual value for the subject property:

Agricultural Land:	\$ 1,200
Non-Integral Residential Land:	\$ 2,500,000

Total:	\$ 4,401,800


4. The valuation, as established above, shall be binding with respect to tax year 2012.
