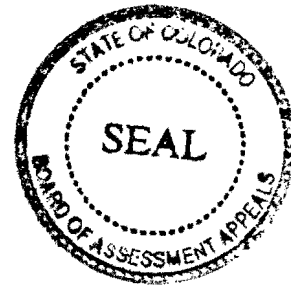

<b>STIPULATION (As to Tax Year 2012 Actual Value)</b>		

Petitioner and Respondent hereby enter into this Stipulation regarding the tax year 2012 valuation of the subject property and jointly move the Board of Assessment Appeals to enter its order based on this Stipulation.

The Petitioner and Respondent agree and stipulate as follows:

1. The property subject to this Stipulation is described as:  
  
Lot 1 Highlands Ranch #63A. 13.174 AM/L
2. The subject property is classified as Residential property.

3. The County Assessor originally assigned the following actual value on the subject property for tax year 2012:

Land	\$ 4,590,841
Improvements	<u>\$15,389,166</u>
Total	\$19,980,007

4. After a timely appeal to the Board of Equalization, the Board of Equalization valued the subject property as follows:

Land	\$ 4,590,841
Improvements	<u>\$15,389,166</u>
Total	\$19,980,007

5. After further review and negotiation, the Petitioner and the Douglas County Board of Equalization agree to the following tax year 2012 actual value for the subject property:

Land	\$ 4,590,841
Improvements	<u>\$14,945,159</u>
Total	\$19,536,000


6. The valuations, as established above, shall be binding only with respect to tax year 2012.

7. Brief narrative as to why the reduction was made:

Further review of market sales information on comparable properties indicated that a change in value was warranted and equalized with the value stipulated to under Docket No. 59994.

8. Both parties agree that the hearing scheduled before the Board of Assessment Appeals on March 22, 2013 at 8:30 be vacated.
