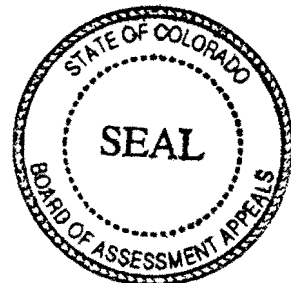

Petitioner, INNER CITY HEALTH CENTER, and Respondent, DENVER COUNTY BOARD OF COMMISSIONERS OF THE CITY AND COUNTY OF DENVER, hereby enters into this Stipulation regarding the tax years 2009 and 2010 valuation of the subject property, and jointly move the Board of Assessment Appeals to enter its order based on this Stipulation.

The Petitioner(s) and Respondent agree and stipulate as follows:

1. The property subject to this Stipulation is described as:

Denver, Colorado

2. The subject property is classified as commercial real property.

3. The County Assessor originally assigned the following actual value on the subject property for tax years 2009 and 2010.

Land	\$	67,500.00
Improvements	\$	<u>640,800.00</u>
Total	\$	708,300.00

4. After appeal to the Denver County Board of Commissioners of the City and County of Denver, the Board of Equalization of the City and County of Denver valued the subject property as follows:

Improvements	\$	<u>432,500.00</u>
Total	\$	500,000.00

5. After further review and negotiation, the Petitioner and Board of County Commissioners of the City and County of Denver agree to the following actual value for the subject property for tax years 2009 and 2010.

Land	\$	67,500.00
Improvements	\$	<u>323,000.00</u>
Total	\$	390,500.00

6. The valuations, as established above, shall be binding only with respect to tax years 2009 and 2010.


