<b>STIPULATION REGARDING PERSONAL PROPERTY</b>	


Petitioners and Respondent hereby enter into this Stipulation regarding the tax year 2013 valuation of the subject personal property, and jointly move the Board of Assessment Appeals to enter its order based on this stipulation.


Petitioners and Respondent agree and stipulate as follows:

1. Actual value assigned to schedule number 71400:  
2013: \$1,538,064
  
2. Actual value assigned to schedule number 71401:  
2013: \$104,851,949
  
3. Actual value assigned to schedule number 71403  
2013: \$ 12,510,758

4. The valuations, as established in this Stipulation shall be binding only with respect to tax year 2013.
5. The valuations reflect application of a 30% economic obsolescence factor to the actual value of the personal property.
6. The parties are agreeing to the actual values set forth in this Stipulation as a compromise of disputed issues, in order to avoid the necessity of further litigation with respect to those issues for tax year 2013.
7. The parties agree that the hearing scheduled before the Board of Assessment Appeals on January 27, 2014 at 8:30 a.m. (20 hours per side) should be vacated.
