1. The property subject to this Stipulation is described as:

4. After a timely appeal to the Board of Equalization, the Board of Equalization valued the subject property as follows:



8. Both parties agree that the hearing scheduled before the Board of Assessment Appeals on Not yet scheduled be vacated.




