A brief narrative as to why the reduction was made: Analyzed market and income information.


The parties have agreed that the 2013/2014 actual value of the subject property should be reduced as follows:

Petitioners agree to waive the right to any further appeal for the assessment years covered by this Stipulation. Respondent reserves the right to account for any value added or subtracted by any 'unusual conditions' that may have occurred between 1/1/2013 and 1/1/2014. **Petitioner does not waive the right to dispute any value added or subtracted by any 'unusual condition' so accounted for by the Assessor.**
