A brief narrative as to why the reduction was made: Analyzed market information.


The parties have agreed that the 2013/2014 actual value of the subject property should be reduced as follows:

Petitioners agree to waive the right to any further appeal of **2075-34-1-36-002** for the assessment years covered by this Stipulation. Respondent reserves the right to account for any value added or subtracted by any 'unusual conditions' that may have occurred between 1/1/2013 and 1/1/2014. **Petitioner does not waive the right to dispute any value added or subtracted by any 'unusual condition' so accounted for by the Assessor.**
