5. After further review and negotiation, Petitioner and County Board of Equalization agree to the following actual value for tax year 2013 for the subject property:



6. The valuation, as established above, shall be binding only with respect to tax year 2013.


7. Brief narrative as to why the reduction was made: More consideration was made to value the subject using the subject's actual base year sales price and other sales in the subject's immediate area.


