4. The Board concurs with the Stipulation.


ORDER:

3. The parties agree that the 2009 actual values of the subject property shall be Stipulated Values below:


\$195,000	\$165,000	Total actual value, with

Petitioner(s) would have all available remedies to dispute the additional assessment for the new or augmented improvements. Should an improvement be destroyed, then the Assessor's Office would make a downward adjustment in valuation to reflect the damage to or destruction of that improvement.
5. Petitioner(s) agree to allow access to the improvements for the purposes of measuring or to obtain building condition information during normal business hours.
6. This valuation is for purposes of settlement only and does not reflect an appraised value.
7. Petitioner(s) agree(s) to waive the right to a Board of Assessment Appeals hearing and any further appeal of the schedule numbers: 075955 for the assessment years (s) covered by this Stipulation.
