3. The County Assessor originally assigned the following actual value to the subject property for tax year 2013:

4. After a timely appeal to the Board of Equalization, the Board of Equalization valued the subject property as follows:

6. The valuation, as established above, shall be binding only with respect to tax year 2013.


7. Brief narrative as to why the reduction was made: More consideration was made to value the subject using the income approach and to take into account the high vacancy rates experienced.


