4. The Board concurs with the Stipulation.


**ORDER:**


**BOTH PARTIES stipulate and agree as follows:**


The subject property is described in Jefferson County Property Schedule Number: 099711.

This information includes actual rent rolls, together with operating income and expense information of the property, which will be provided to the Assessor no later than March 15<sup>th</sup> of each year.~~ *Unable to affirm as our contract limited to specific value years.*
6. Petitioner(s) agrees to allow access to the improvements for the purposes of measuring or to obtain building condition information during normal business hours.
7. Petitioner(s) agree(s) to waive the right to a Board of Assessment Appeals hearing and any further appeal of the schedule numbers 099711 for the assessment years covered by this Stipulation.
