STIPULATION (As to Tax Year 2013 Actual Value)

Petitioner and Respondent hereby enter into this Stipulation regarding the tax year 2013 valuation of the subject property and jointly move the Board of Assessment Appeals to enter its order based on this Stipulation.

The Petitioner and Respondent agree and stipulate as follows:

1. The property subject to this Stipulation is described as:
Lot 5 Park Meadows Town Center 1A, 3rd Amendment. 1.131 AM/L.
2. The subject property is classified as Commercial property.

3. The County Assessor originally assigned the following actual value on the subject property for tax year 2013:

Land	\$ 896,648
Improvements	<u>\$ 643,418</u>
Total	\$1,540,066

4. After a timely appeal to the Board of Equalization, the Board of Equalization valued the subject property as follows:

Land	\$ 896,648
Improvements	<u>\$ 643,418</u>
Total	\$1,540,066

5. After further review and negotiation, the Petitioner and the Douglas County Board of Equalization agree to the following tax year 2013 actual value for the subject property:

Land	\$ 896,648
Improvements	<u>\$ 493,352</u>
Total	\$1,390,000

6. The valuations, as established above, shall be binding only with respect to tax year 2013.


7. Brief narrative as to why the reduction was made:


Further review of account data, three approaches to value, with greater weight given the sales comparison and cost approaches, indicated that a reduction in value was warranted.

8. Because 2014 is an intervening year, the parties have further agreed that the 2014 value shall also be adjusted in order to make it consistent with the 2013 value.

9. Both parties agree that the hearing scheduled before the Board of Assessment Appeals on April 24, 2014 at 8:30 be vacated.
